This has reference to your grievance dated 22.09.2014 regarding toll collection in Hyderbad-Bangalore section of NH-7, the parawise reply for your grievance is furnished as under:

- .1. At a time of going to Airport, there is no collection of fee while coming from Airport and going to Bangalore, Toll fee is collected for return journey, as per the Government of Karnataka order.
- 2. Only in Toll Plaza- 1 return journey time will get expired at the time of issuing ticket as user fee is being collected for return journey.
- 3. While travelling from Whitefield via Devanhalli, road users is getting free ticket at Toll Plaza -4 near trumpet which should be shown in Toll Plaza -1. Then the ticket will be scanned and automatically a single journey ticket will be generated otherwise it considers return journey.
