Sub.: Request for exemption from the user fee (Toll) charges levied at the toll gate and response to the notice issued by the toll plaza.

Sir,

This is with reference to your email dated 01.11.2014 and later on your letter dated 01.11.2014 addressed to Chairman, NHAI on the above subject. In this regard, the following is informed:

- (i) The toll plaza at Chennasamudram falls on Walajhapet-Poonamallee section of NH-4 which has been developed as 6-lane facility by the Concessionaire (M/s. Essel Walajhapet Poonamallee Toll Road Pvt. Ltd.) on Design, Build, Finance, Operate and Transfer (DBFOT) Toll basis. In a DBFOT (Toll) project, the cost of Design, Construction, Finance and Operation & Maintenance upto the end of Concession Period is born by the Concessionaire and he is permitted to collect the user fee from the vehicles as per the terms and conditions of Concession Agreement during the period of Concession.
- (ii) User fee (Toll) collection at Chennasamudram toll plaza is as per the provisions of Concession Agreement and National Highway Fee (Determination of Rates and Collection) Rules 2008, as amended and the concessions/exemptions are to be given by the concessionaire as per the provisions mentioned therein. As per concessions/exemptions available as per provisions of Concession Agreement/Fee Rules, which may be viewed on the website <a href="www.nhtis.org">www.nhtis.org</a>, there is no waiver available to educational institution (only monthly pass for 50 or more types at 33% discount is given).
